Description of Proposed Works
Please describe the proposed works
Timber frame and cedar cladding to cover a paddling pool for aesthetic purposes. Timber steps to enter and exit pool only. Formation of flat clad section to encompass dimension's of the paddling pool (paddling pool "bellies out" at the bottom so the base is wider than the top, which creates the need for a clad top section). The flat clad sections are not suitable to be walked on and are therefore not considered decking, as they are not designed to take the weight of pedestrian traffic and the cladding is not suitable material to be walked on. Further, fixed lightweight barriers will be permanently attached to the complete perimeter of the paddling pool cladding, and the entry/exit steps, to ensure that the top section cannot be walked on, and that the steps are limited to entry and exit only. The fixed lightweight barriers will be provided in the form of permanently attached planters with artificial foliage to ensure permanence of installation.
