T1 - Pine - roots are damaging a nearby block paving area (see pictures) which is 6m east of the tree. The pine measures 14m in height itself with a diameter of 0.7m, the tree has a slight lean to the south and the overall condition of it is good. We are not planning to complete any works to the actual tree, but to cut roots no greater than 60mm in diameter (which are 6m away from the tree) in order to repair the block paving.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
