2. Introduction

2.1 We have been commissioned to provide architectural services to improve the existing property following the purchase by our clients. There have been various works carried out the property by previous owners which are now felt to need to be replaced to restore the listed building status of this building.

Prior to our commission our clients met with a member of the Conservation team from the local planning authority and discussed their vision for the home and for confirmation of the information required with a future planning/listed building consent application.

The existing property is know as 'All Hallows Cottage' and is a Grade II listed building. Please see the relevant information within this statement.


3. Proposed Works

- 3.1 Our client is proposing to carryout the following works:
- a. Replace the existing timber fence with a brick wall. The wall is located between the rear of the house and the previously constructed garage;
- b. Carefully take down the existing conservatory and replace with a traditional 'Orangery' brick structure;
- c. To replace 3no. upvc windows with traditional timber windows to the rear elevation;
- d. To provide new window to side elevation (dining area) to match the existing timber windows.
