The tree is a Grey Poplar, and this application is to prune the tree by c.20% in order to prevent unwanted wind damage and any branches falling into the property's garden and neighbouring gardens. Additionally it's close to a neighbour's house (37 David Bull Way). I believe the conservation area was set up prior to the tree being planted as years ago Elm trees used to grow in just outside of the garden (prior to the estate being built in David Bull Way), otherwise the area is various residential gardens. A separate enquiry has been sent on this matter.
