T1 Line of Lime trees opposite flats and car park, to prune back side branches from flats and car park by 2 meters back to old pruning cuts. The Owner want to keep the tree back from the flats and car park as they are now starting to encroach.

 - showing the approximate distance between the application tree(s) and buildings
