Reasons for work: The removal of SB is being requested due to the increasingly hazardous and excessive lean towards owner and neighbouring property. The tree is within 5 metres of both properties.

The size of the SB, and the frequent dropping of branches, indicate it is nearing end of its lifespan.

6. Tree Preservation Order Details

Identification Of Tree(s) And Description Of Works continued ...

The garden of 11 Oakroyd Close, is used regularly by children aged six to ten. Falling branches/ possible fall of the SB, pose a potential threat to the safety of the children, and both homeowners, particularly with the increasingly frequent adverse weather conditions.

Lean has been exaggerated towards properties through previously approved work which left limbs on property side only. Regular measurements have been taken over time, suggests the lean is increasing. The previously approved work was unsympathetic and so negates the amenity value of the SB.

The SB has a high density of seasonal seed, catkin and leaf drop, leaving the properties and road with regularly blocked gutters and overflowing drains. The Royds area already have raised concerns with blocked drains, of which the council are aware.

Wildlife such as squirrels and birds favour the native and established oak trees and surrounding bushes and fauna.
