Bay 1: NW corner by house; 8m ht/ multi-stemmed/ spread 3m N, 2.5m E, 3.5m W, 4m S – reduce main central trunk [Ganoderma sp. conk at base, see images in attached documents], balance prune remaining over hanging canopy back from neighbouring property – to maintain tree within its space and mitigate impact on neighbouring property.

Bay 2: E side; 8m ht/multi-stemmed [7 main trunks 12-22cm dbh/ 8 smaller stems < 10cm dbh]/spread 4m N, 3m E, 3.5m W, 2.5m S – remove smaller stems (which will lift canopy), clip canopy all round by 0.75-1.0m to reduce to 3x2.5x3x2m, and reduce/balance prune overall ht to 6.5-7m – this is to improve light to planned under planting, and manage tree within its space in the garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
