Whilst a large outbuilding due to the land levels would appear partially subterranean and as such would not be immediately visible unless viewed from the rear. The outbuilding due to its rear location would not have any impact on the street scene. Any land level changes should be shown on relevant sections within an application. Landscaping changes should be shown on site plans or dedicated landscaping plans with information relating to materials, species etc. to avoid condition. It is recommended that hard landscaping is limited to maintain the verdant character of the site.

The pool house due to its location at the bottom of the garden, being single storey and partially sunken is unlikely to cause any neighbouring issues to those located on either side. Those to the rear should also be taken into consideration. With alterations to site levels and a terrace area on the subterranean pool house it would depend on the boundary treatments and overall height.
