My rear garden has one large lime tree to the left of the property, clearly visible from Trevor Hill - its not possible to confuse with any others some 5 metres from the north east corner of the property.
The Crown was reduced by about 1.5 - 2m 10 years ago, similarly 5 years ago and I would like the 1.5 - 2 m regrowth trimmed back again now ie the crown reduced by 1.5 to 2 m all over maintaining the fine shape of the tree.

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

To reduce the crown of the lime tree all over by 1.5m to 2m all over whilst maintaining to shape of the tree. Similar work was undertaken 5 years ago and 10 years ago. The tree is some 5 metres to the north east of my property in the back garden, and stands alone, so cannot be confused with others. It is on a very steep slope and can easily be inspected from Trevor Hill Road, or by walking around the side of the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
