LARGE 40'x30' WILLOW TREE LOCATED IN THE REAR GARDEN OF DALE COTTAGE. IT IS SITUATED AGAINST AN HISTORIC BOUNDARY WALL WHICH HAS BEEN CAUSED TO CRACK THE WALL + IN TURN, CAUSED THE WALL TO LEAN INWARDS INTO RIVERSIDE MEWS. THE TREE DEPOSITS LEAF BRUSH HUSKS IN SPRING; THEN IN AUTUMN, DROPS EXCESSIVE AMOUNTS OF LEAVES. STREAMERS DRAPED OVER VENTILATORS CAUSING SEVERE DAMAGE TO PAINTWORK. LEAF DROP CAUSES MECHANICAL ISSUES AS THESE BECOME TRAPPED IN VENTS. LEAF DROP CAUSES BLOCKAGES IN RIVERSIDE MEWS' DRAINS. TREE ROCKS WHEN GENTLY MOVED - IT'S DANGEROUS.

WORKS TO BE COMPLETED: TO REMOVE THE TREE COMPLETELY ON THE GROUNDS THAT IT IS THE WRONG TREE IN THE WRONG POSITION; IT IS DANGEROUS + POSES A RISK OF FALLING - PARTICULARLY IN HIGH WIND. IF FELLING THE TREE ISN'T SANCTIONED, A REQUEST TO CUT BACK BRANCHES / STREAMERS TO BOUNDARY WALL OR TO THE TRUNK OF THE TREE TO ENSURE IT ISN'T LEFT UNSIGHTLY WHEN BEING PRUNED. THIS WILL REQUIRE LEANING INTO THE GARDEN BY A MATTER OF FEET IN ORDER TO PRUNE BACK TO THE TRUNK / CROWN. ESSENTIALLY CROWN REDUCTION / THINNING PLEASE SEE PREVIOUS APPLICATION WHICH OUTLINES PREVIOUS DANGERS THE TREE ~~THAT~~ POSES WHICH THE OWNER GEOFF PHILLIPPS CONTINUES TO IGNORE.
