T19; London Plane - tree has a very large cavity at the base and is within close proximity to the car park. Pollard to approximately 50% of current size and plant a heavy standard London Plane within 4m, with a view to dismantle the existing London Plane to ground level once the replacement tree has reached an approximate height of 10m.

T26; Atlas Cedar - remove 1x snapped limb and reduce weight on remaining limbs by removing deadwood and reducing over-extending branches.

T30; Holm Oak - reduce canopy by approximately 40-50% due to multiple limb failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
