Details of the pre-application advice received

"It is...proposed to renovate the main façade and shopfront of the building including removing and replacing the glazing in the shopfront, potentially removing and replacing the secondary entrance door on Old Bond Street. These works are all acceptable in principle, dependent upon the detailed design...the existing shopfronts, whilst modern, are of a high architectural quality including nice margin lights, and have a positive impact on the streetscape. The proposed shopfronts are simpler in design, consisting of clear frameless glass and would not have the same positive impact. The detailed design of the new shopfront windows should be further developed to ensure that they are of high architectural quality and positively enhance the character of the area."

UPDATE 1: Application 23/02689/FULL was Refused with the following Reasons: "Because of the loss of mullion and transom details the replacement windows would harm the appearance of this building and fail to maintain or improve (preserve or enhance) the character and appearance of the Mayfair Conservation Area."

In response, the proposed design was updated to feature intermediate and integral glazing bars reflecting existing mullion and transom details and it was this that was Approved under 23/04701/FULL.

UPDATE 2: The proposed Entrance Doors follow the design of the Approved shopfront in all respects.
