Removed of a 25-30 ft tall ornamental cherry tree from my back garden along with the roots. The tree is damaging both mine and the neighbours gardens as it has grown out of control. Both parties support this application. We also plan pruning work on 3 to 4 other trees to protect them from over growing and to enhance conservation of them into the future.	
The above work has been advised by a local tree surgeon post a site visit 2-3 weeks ago.
