My client wants to reduce his lime tree by 4-5 Meters, he already has had a large limb rip off of the tree which nearly hit his house. Due to this event he is keen to reduce his tree.

Identification of Tree(s) and Description of Works

My client wants to reduce his lime tree by 4 - 5 meters in places, we have informed him that we want to always be cutting into a decent growing point as we don't want to pollard the tree, as the regrowth from these points will be brittle and he will need to have his tree cut even more regularly.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
