Single storey detached stable building located to the northeast of the main house, clad with timber weatherboards and a corrugated metal roof.
Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?
The stable building was granted planning permission (22/02086/FULLS) and listed building consent (22/02087/LBWS) to be refurbished and converted in 2022. Following structural investigations, it was deemed that the existing structural timber elements were in poor condition, with well-established decay found throughout. In addition, the existing floor slab was deemed to be of poor agricultural quality and is currently cracking.
