**Full Planning Permission for Replacement Roof and Erection of Canopy at The Hollies, Auchenblae, Aberdeenshire, AB30 1XR**

I refer to your application for the above. Under the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 there is a legal requirement for the public display of the attached notice for a period of not less than 7 days.
