The tree sheds twigs and small branches every day. Bird perch in the branches and defecate near constantly onto the driveway, pavement, bins and cars parked in the vicinity. The photos show the branches and bird mess dropped just a few days after the drive and cars were cleaned.

At around 8am on 8th June 2019, a large branch from this tree fell onto the pavement/roadway causing £360 worth of damage to my car parked on Lyndhurst Road. It was fortunate that local parents and children were not on their way to school at the time of this incident. The incident was reported to Development Control at North Tyneside at the time and tree surgeons were engaged to check for dead wood and trim the trees to the preservation order.

That was almost 5 years ago and this needs to be done again, especially in the light of increasing wind speeds due to climate change.

## Identification of Tree(s) and Description of Works

This is the large ash tree located at the north east corner of the garden at 8 Lyndhurst Road and overhangs 10 Lyndhurst Road and the public pathway and roadway of Lyndhurst Road.

Engage tree surgeons to identify and remove dead wood and to prune and/or remove branches that overhang the driveway of 10 Lyndhurst Road and pavement/roadway of Lyndhurst Road.

Tree surgeons to identify and remove dead wood and trim the other trees in this area appropriately.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
