Installation of a Samsung 12kw (nominal) heat capacity air source heat pump to replace existing gas boiler. This will reduce combustion of fossil fuels in line with UK government guidance. The proposed installation is to the rear of our property and is 3.6m away from the boundary with our nearest neighbour. We are seeking permission as the external dimensions of the outside unit; 1270mm (W) x 1018mm (H) x 530mm (H) exceed the 0.6 cubic metres under permitted development.
