2. Remove the provision of a Balcony to the rear elevation and replace with a single landscape Window 2800mm x 1500mm (Cost Save).
3. Split the two storey feature window to the front elevation at the first floor level (Cost Save).
4. Southern Kitchen Window to Extension moved 300mm (Design Correction).
