- 1. A large dead elm tree (approx 8m tall) at end of garden. This has been dead for at least 2 yrs and needs to be felled.
- 2. A smaller dead elm tree (approx 5m tall) on right side of garden next to summerhouse. This has been dead for at least a year and needs to be felled.
- 3. A dead willow tree on right garden border half way down (approx 5m tall) has also been dead for about 18mths and needs large dangerous overhanging branches removed. The main trunk (approx 2m tall) can remain to decay naturally.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
