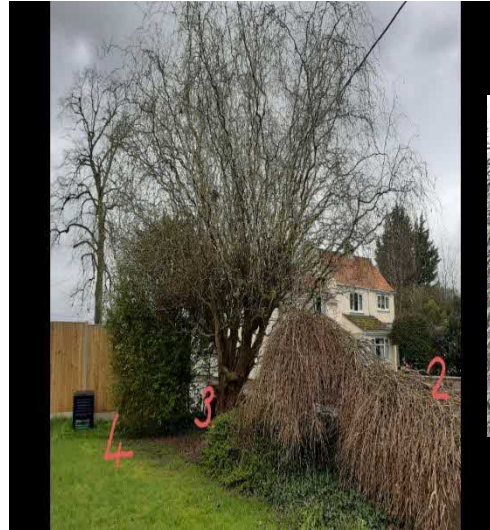

1. Conifer. Request to Fell.
Too close to the house. Body of the tree approx 30cm from house wall. Obstructing window.
2. Grey Willow Bush. Request to Fell.
Main body of tree branches intertwined with no growth. The top branches lie on the dwarf wall, approx 2m) and trail on the ground / pavement. The dwarf wall is showing signs of deterioration under the weight and close proximity to the wall.
3. Corkscrew Willow Tree. Request to pollard.
Height and volume enough to interfere with overhead cables, over the pavement and into the road.
If not allowed to pollard then crown reduction to approx 3.5m and crown lift to 2.5m curbside.
4. Privet hedge. Trim & Crown reduction (or topping) to approx 2.5m.
5. Salix. Seasonal Prune.

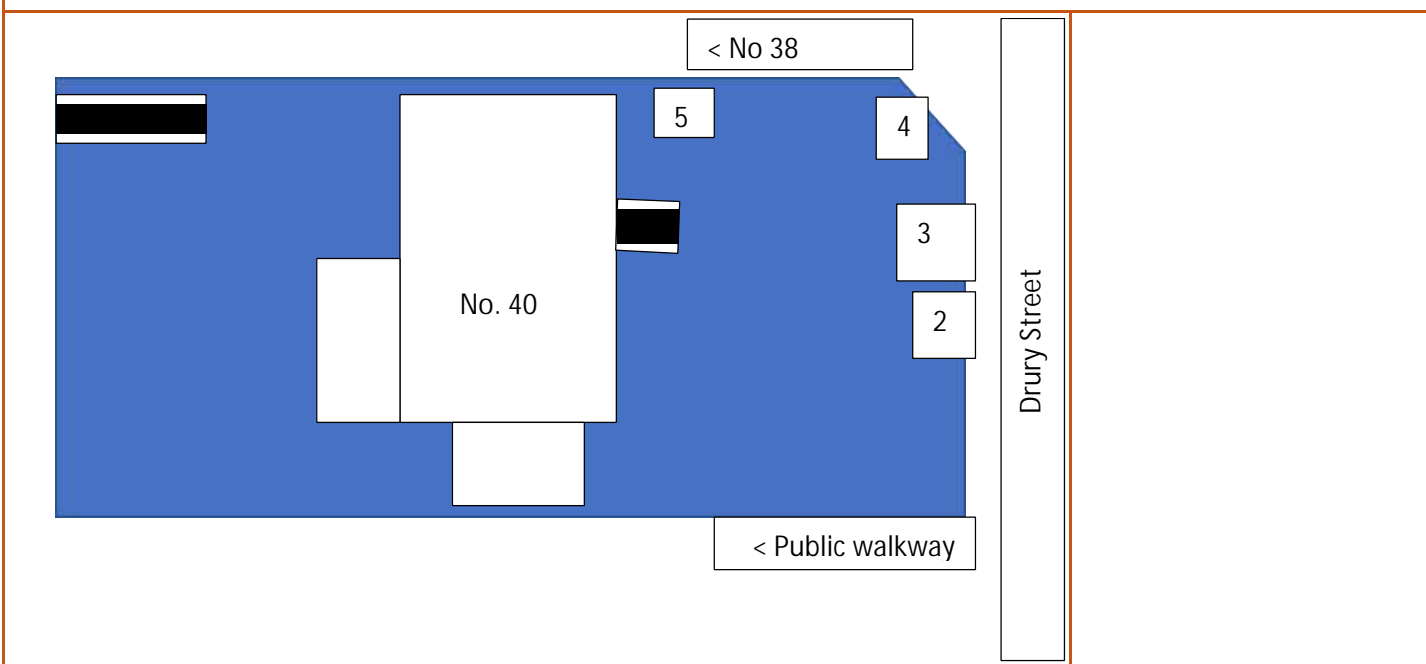
