Proposed work to Beech tree under TPO for general crown lift. Low branches are now on the ground and are a hazard to young children present in the garden along with encroaching on boundary to neighbours. Natural shape and character will be maintained with the goal of ensuing the tree stays healthy for longer and safe.
