The oak tree growing at an angle out the side of a bank in the wild life corridor is very exposed with a heavy lean towards the property below. Some of the limbs are cracked and split. All the trees and vegetation in the hedge have either been removed or reduced hence it is exposed to the wind. I am to perform a crown reduction to bring the crown back in line with the existing trees. Also to remove the failing limbs due to cracking and try to reduce the weight on the lower side.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
