T1 (00AV), T2 (00AW), T3 (00AY), T4 (00B0), T5 (00B1), Prunus autumnalis, Initial crown lift to give 4m clearance from top of steps to allow for materials to be carried in and out of garden during roof repair works (planning Appn. No.: 23/00532). This will allow the trees to remain in place whilst the work is being carried out. On completion of the planned work, remove and replace the 5 trees if required as they will be poor specimens and likely to have declined in health due the previous crown lift.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
