It is a 50 foot Lime tree that borders us and our neighbour and was planted by the previous owner (we've been here for 28 years) right up against the hedge. We only need to have the height brought down as it is definitely overshadowing our neighbours garden, which is causing them distress.

The branches just need topping off. We have employed a tree surgeon to do the work correctly and to shape the tree in a better way.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
