Row of 12 Lime trees within car park boundary at Park Hall Hotel. Removal of all epicormic growth from lowermost 3m of stem to remove the risk of obstruction to people and vehicles along with improvement of the trees aesthetically. Trees within yellow area on drawing 1. See photo 1 showing epicormic growth currently.
