T1 Sycamore Removal to ground level and stump ground out.

A mature example at the periphery of a shelter belt but within the garden of the property. The tree has twin leaders with signs of include bark in the main union, approximately 4 meters from ground level. Its growth, having been constrained by the neighbouring trees of the shelterbelt, exhibits a pronounced lean towards the south. Consequently, the crown's weight is disproportionately distributed, looming over the adjacent garage and house.

It also exhibits historical damage at the buttress roots on the north face of the tree, indicating possible past harm to the root system and root compaction. To mitigate potential hazards to the surrounding property, it is advisable to consider the tree's removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
