Description of Proposed Works

Please describe the proposed works

To replace existing 5 bar gate which measures 4.8m wide x 1.5m height with a pair of new solid infill curved top aluminium gates in graphite grey measuring 4m total combined width x 1.8 m high at posts rising to 2m high in centre. There will be a clearance of approximately 35 - 40mm at the bottom. The wooden posts will be 200x200mm and will be approximately 2m in height including weather top in a matching colour. The gates will be automatically operated using remote fobs and GSM intercom enabling remote opening from a mobile phone. The gates will open inwards to the property and will be prevented from accidental opening onto the highway by a secure ground stop. Infrared beams will prevent premature closing. An exit button will also be installed. The gates will be in line with the existing conifer hedge row which is approx 3m in height. The gates will be installed by an approved installer.

A 1m wide threshold of grey block paving will be incorporated into the shingle driveway between the gate posts.

The gates will be of a matching style and similar size to those installed at the neighbouring property, Hillside House and will provide an increased level of privacy and security over and above that provided by the existing gates, the posts of which have decayed and collapsed.
