Reason: Clay shrinkage subsidence damage at neighbouring property 27 High Street, CV35 8BU. NOTE: S211 Notifications are also being submitted regarding recommended works to T1 Purple-leaved Plum and TG2 Cypress Group of the MWA Arboricultural Report.
