T1 is a Cornelian Cherry Dogwood (Cornus mas). We plan to lift the crown over the tent to create 2m clearance from the structure. Lift to 3-3.5m over the garden area to create more head room.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
