Group tree identification number G7. Lime, Horse Chestnut and Beach. Removal of dense epicormic growth around Limes, reduce beach by 3m due to large basal/stem wound of 0-2m.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
