Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Large pine tree at front of property: several large branches have fallen in recent high winds onto our driveway, our neighbours' driveway and onto the Toob broadband wires under the tree causing potential danger to ourselves, our neighbours and passing pedestrians. The tree has been assessed by a local tree surgeon. The tree itself is healthy but unbalanced. Due to an excessive leap we are seeking to remove 3 limbs

from the top of each stem to reduce the weight on the lean and prevent tree failure. Also there is a limb which is almost touching the electrical cables running through the tree which should be removed.

Two Norway Maples, one oak in rear garden of property: crown reduce 3 trees back to previous reduction points to manage overall size of trees and ensure longevity. This maintenance has been previously agreed and carried out (application 19/02054/CA)
