Description

Erection of a 2.4m high 38m long metal security mesh fence with a powder coated green finish, stretching from the school side (north of the bridge) of the perimeter fencing on Lucas Road, to the internal fence/gate bordering the sports car park. To prevent access from the other side (south of the bridge) we wish to erect a 6.1m long fence of the same height and style inside school grounds, which will border the property at 29 Lucas Road which currently has a fence 1.8m in height.

We also wish to automate the internal gates that are currently operated manually, so that access is via electronic fob only. This will require the installation of a post and card reader for access.

Students from other schools in the area have been coming onto the school site and congregating on the path under the bridge below Lucas Road, that allows our students safe access to and from the playing fields. Damage has been caused to the tunnel gates and padlocks stolen which has cost the school to repair/replace. Wheelie bins have been dragged into the space and set on fire. This project will prevent members of the public gaining access to the school site and stop students leaving site without permission during the school day, ensuring that our requirements are met in terms of site security and safeguarding of our students and staff.
