Full Planning Permission for Alterations to Dwellinghouse at Avonlea, 7 East Park Street, Huntly, AB54 8JE

I refer to your application for the above. Under the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 there is a legal requirement for the public display of the attached notice for a period of not less than 7 days.
