ASSESSMENT OF EXISTING SOIL CONDITIONS AND SURFACE WATER MANAGEMENT FOR PROPOSED EXTENSION

We refer to your e-mail seeking a fee proposal in respect of the above. It is understood the intent is to build a new extension located at Mannachie Lodge, Forres and you require support in the form of bearing capacity testing and drainage design.

Scope of Work

Subject to your authorisation, Mabbett will provide the following services:

- Site visit to witness excavation of trial pit and carry out bearing capacity test for proposed foundation.
- Carry out Infiltration testing to BRE Digest 365.
- Provide a ground investigation report to include details of findings, bearing capacity and infiltration rate.
- Provide drainage design for new roof area.

The proposal does not include for the hire of an excavator as it is anticipated this would be provided by the client. Should Mabbett require to arrange the excavator, the contractor would invoice the client directly.

Budget

We propose to provide the services as defined above, for a professional fee which is determined based on a special hourly rate.

A service charge of 15% to cover the cost of administration and coordination, will be applied to the invoice cost of special outside technical services (e.g., analytical laboratory, etc. and to the cost of all reimbursable expenses except travel, per diem, car rental, and professional liability and general comprehensive liability insurance costs). Reimbursable expenses are defined to include such items as travel, per diem, reproduction, communications expenses, field supplies and materials, computer equipment use, and professional liability and general comprehensive liability insurance costs, etc. The cost of all special outside technical services and reimbursable expenses are in addition to our professional fee.

Although you will only be billed for actual services provided by Mabbett, we recommend that a combined not-to-exceed budget of £650 be established, inclusive of professional fee and miscellaneous

reimbursable expenses.
