1 - clump of sweet chestnut trees along left hand rear boundary - dismantle to approx 2 feet under hedge height. To include the Oak tree thats growing within them.

2- Eucryptia Columnar in rear garden - remove dead stem and reduce the remaining stem by approx 2-3 meters, leaving an overall height of 7-8 meters.

- 3- Veriegated Holly on right hand side of rear garden reduce height by approx 2 1/2 meters leaving an overall height of 4-5 meters.
- 4- Acer on right hand side of rear garden with lifting root plate dismantle to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
