The Willow Tree is to the Rear of the Property. The Canopy currently overhangs the property, the mooring, and the neighbours garden which results in excessive shading and damage to the property due to falling debris.

The application requests a reduction by the following amounts (see REF 3) T1 = 2metres, T2 = 1 metre, T3 = 1 metre.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
