T1 Lime - Remove epicormic growth up to the first branch brake.

T11 Lime - Remove epicormic growth from stem base up to the first branch brake.

T12 Lime - Fell. Specification to include complete removal by sectional dismantling. Leaving the main trunk at 3m in height as a monolith habitat pole.

T13 Lime - Remove epicormic growth from stem base up to the first branch brake.

T22 Sycamore - Crown thinning and weight reduction work to include, reduce overall canopy weight by 20% target pruning larger branches.

Cable brace install at 11m a Cobra dynamic system, bracing two stems together for added safety.

T29 Birch trunk - Silver Birch fig 2, requires removing. Fell to ground level.

T31 Lime - Remove epicormic growth from stem base up to the first branch brake.

T33 Walnut - Crown thinning and weight reduction work to include, reduce overall canopy weight by 15% target pruning larger branches. To alleviate loading on union.

T104 Lime - Remove epicormic growth from the stem base up to the 1st branch break.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
