Following the fire at Grenfell Tower on 2016 Building Control have nationally revised the requirements under approved document part B to remove any combustible cladding form the exterior of any residential building with a floor over 18 m above ground level.

This building is being re-clad to address these issues, replacing the insulation with A1 or A2 rated solutions. The proposed cladding systems will allow for facing material to closely match the existing where possible, all facing materials samples required by the local authority for approval from part of this application.

The current site contains a single building comprises of one block to the west end of the site of five floors, all residential accommodation, the middle block comprises of eight floors, all residential accommodation and one block to the east end of the site consisting of thirteen floors, lower ground floor consists of a Gym, management offices, plant rooms, external cycle store and bin stored, upper ground to floor thirteen consist of residential accommodation. The building is clad with facing Blockleys Black Smooth standard size walled stretcher bond brickwork, to a majority of all elevations of the building, timber cladded facade to the south elevation lower ground floor of the five story building smaller building with one area of five stories to the east end of the smaller building. Timber cladded also exists to the high level terrace areas of the east end of the 13 story building. Fundermax high pressure laminated feature panels are located to the external projecting balconies and silver colour powder coated aluminum feature pods to the Juliet balconies.
