"Notwithstanding the approved plans, no works above the damp proof course level shall be carried out until full details of the design, external appearance and decorative finish of the new secure line fencing to the front of the site have been submitted to and approved in writing by the local planning authority. The development shall be carried out in accordance with the approved details prior to the first use of the development and shall thereafter be retained".

## Condition 25 states:

"Prior to the commencement of the development above the damp proof course, a scheme of measures to minimise the risk of crime according to the principles and physical security requirements of Crime Prevention Through Environmental Design (CPTED) shall be submitted to and approved in writing by the Local Planning Authority. The submitted details shall demonstrate that the scheme has been developed in consultation with Kent Police. The measures so approved shall be implemented in full prior to first use of the development and shall be retained".
