We are proposing to install a new front door and frame to match the original designs. The glass will be replaced with encapsulated leaded units to match what would have originally been installed, matching the designs at no. 32 Woodfield Avenue (see photos and drawings). The current door has only one panel of glass at the top (would have been three panels originally). In addition, the door is warped and there are significant gaps between the door and the door frame. It is not possible to refurbish to make good and match existing designs.
