Tree/group numbers as identified in the attached report (which includes individual descriptions and a site plan).

Felling has been identified as low/moderate priority for: T39, T40, T48 and T51, and one tree in G85. - these are marked on appendix 5 of the attached report in red.

Pruning has been identified as low/moderate priority for: G23, G65, G70, T73, T74, T77, T78 and G84, and one tree in each of G85 and G87. - these are marked on appendix 5 of the attached report in blue.

While these works have only been marked as low/moderate priority, funding is currently available for larger items of maintenance work to the Todmorden site. The ownership of the site may soon be passing from the Historic Chapels Trust to the local group who currently run the day to day use of the church. We are keen to pass the site over in as good a condition as possible.

The attached report includes detailed descriptions of each tree and the proposed felling/pruning details in appendix 1. This report is being used as the basis for quotes from local arborists to undertake the work. Given the nature of the site as a graveyard, we are proposing removal of all felled/pruned material offsite following the works.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
