T1. Apple Tree- Reduce and re shape by approx 1m leaving a finished standing height of 3.5-4m with a radius spread of max 1.5m- The work is to re balance due to being crowded by neighbouring trees leaving with a poor habit

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
