T1 Beech tree located on the left hand boundary in the rear garden

The tree is becoming overmature for its location and is beginning to suppress the surrounding garden; however the canopy of the tree does provide a good screen to the neighbouring commercial buildings.

I advise the tree is re structured by approximately 60%

T2 Sycamore located in the front garden adjacent to the front boundary

The canopy of the tree is starting to encroach upon the driveway and entrance to the property.

Therefore I advise the removal of any dead wood over 30 mm in diameter and to laterally reduce the lower canopy by up to 2.5 metres from the branch tips back to suitable growth points.

Also to raise the canopy to 4m from ground level by removing the lowest limb back to where it originates.

This action will help to contain and shape the tree.

G1 Silver birch x2 located on the verge closest to the entrance

The trees have been planted underneath overhead services and now pose a maintenance issue.

As the trees are still quite young I advise the trees are reduced to approximately 1.5m below the phone lines and the remaining canopy pruned to shape.

This action will help to contain and shape the trees.

G2 Group of 4x Sycamore trees located on the verge adjacent to G1

The trees are semi mature in age and as a result of growing in close proximity the canopies are asymmetrical and leggy.

Due to the species age and form of this group of trees I feel it is best to remove the trees down to ground level and to remove the stumps to allow for re planting of a more suitable species that will bring a greater amenity value to the area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
