T1: Sycamore. Removal to ground level and grind out resulting stump to enable the widening of the entrance from Cow Lane into the car park. Approval for this work was granted in 2020 Ref : 20/01411/TPO but COVID prevented the work being completed and the approval lapsed. The club are now in a position to resume this project.
