T1 - Mature Cherry - This tree is in good health. It has not be managed for many years. The crown is very dominant and is causing excessive shading to the property, both inside the house and in the garden. Its crown is also now interfering with both the roof and also the road. Larger vehicles are being impeded by the crowns spread over the road.  Request a 2.5m Crown Reduction to growth points where possible.

G1 - This group of 4 young self set Sycamores have become very dominant. They have never be managed. They are causing excessive shading to the property below. They are also causing access issue with larger traffic on station road. They are also interfering with the crowns

Request permission to pollard these threes back by 4m to behind the boundary fence and also reduce them in height by 4 m.
