TPO 1995 No.1:

Trees 1-7, which those trees growing in the gravelled area, to be removed to facilitate further expansion of the hospital. These trees have had honey fungus, historically. The owners are keen to plant other trees, of an appropriate size and approved species, elsewhere within the hospital grounds

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

Amendments Summary

The exploratory proposal is to remove a 7 trees growing within the gravelled car park. The would allow for further expansion of a restricted site. The owners are willing to replant more trees of a suitable size & species elsewhere on the hospital grounds. Historically in this area trees have been lost to honey fungus, which is likley to still be present. At the time the whole area was treated using an air spade, and improved surface protection, which does seem to have stopped more trees failing. With the pressures for space at the hospital this application is made asked to be approved.
