| 13 metre Ash Tree (T1) - To reduce back three limbs by 3 metres which overhang the client's garden. The limbs are drawn, they shade the garden and encroach on its space. |
| 2 Yew, 1 Holly, 1 Hazel (T2) - This group of trees is roughly 9 metres tall and forms a screen between the property and the neighbouring |

Boathouse Pub. The trees have become tall and block out afternoon sunlight. The client would like the screen to remain but to reduce its

height by 3.5 metres. They would like to do this so the height does not get out of hand and to allow more light into the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
