Yew (T1) Reduce back the north side of the crown by up to 2.5m so that the trees does not overhang the pathway. Crown lift to 4m (secondary laterals) to clear the parking spaces on Christ Church Road and to lift the tree to allow more natural light into the windows on the south side of the church.

Yew (T2) Reduce back the north side of the crown by up to 2.5m so that the trees does not overhang the pathway. Crown lift to 4m (secondary laterals) to clear the parking spaces on Christ Church Road and to lift the tree to allow more natural light into the windows on the south side of the church.

Holly (T3) Reduce back the north side of the crown by up to 2.5m so that the trees does not overhang the pathway. Crown lift to 4m (secondary laterals) to clear the parking spaces on Christ Church Road and to lift the tree to allow more natural light into the windows on the south side of the church.

Holly (T4) Crown reduce by approx 2m in height and 1m laterally. Crown lift to 2.5m and remove ivy.

Sycamore (T5) Reduce back the lower branches on the west side of the tree by 2m to maintain a suitable clearance form the east elevation of the church.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
