A reduction of an Oak situated on the Grass verge to around 12m above ground level. The work is needed to be done due to a telephone communication masts to be upgraded and the trees would interfere with the signal. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
